Preparing for the Class III and Class IV Certification Exam (Five Sessions)

This five-session course helps students move beyond the basics to a deeper understanding of the operation of wastewater treatment plants. It provides invaluable instruction for those preparing for Class III and IV certification exams. To enroll, you should have existing understanding of the basic principles in the Sacramento State University Operation of Municipal Wastewater Treatment Plants, Volumes 1 and 2, as well as SSU's Advanced Waste Treatment.

Participants will receive instruction in the mathematical calculations used in wastewater treatment and likely to be encountered on the Class III and IV exams. **Students must bring a basic calculator.**

IMPORTANT COVID-19 INFORMATION FOR IN-PERSON COURSES

PLEASE NOTE:

- **Checks/Money Orders:** Should be made payable to "NEIWPC Training". There is a \$15.00 returned check fee.

- **Cancellations/No-Shows:** Seven days notice is required IN WRITING (mailed or faxed) for you to cancel at no cost. Cancellations received after this time will be charged \$25 for programs under \$125 and \$50 for programs over \$125. Registrants who do not cancel and who fail to show are responsible for full payment.
- **TCHs:** Participants must attend all hours of training to be eligible for Training Contact Hours (TCHs). TCHs are awarded upon completion of a course. Courses have been approved for only wastewater TCHs unless otherwise noted.
- NEIWPC reserves the right to postpone, reschedule, or cancel any course if needed.
